# **Program Summary:**

The goal of Hispanic Unity's VITA program is to provide a top quality, 100% f<u>ree</u> tax preparation service for low to moderate income families throughout Broward County. Paramount to this effort is that the program assists clients in identifying and accessing all eligible tax credits to maximize the refunds brought back to the community.

#### **Program Goal:**

The goal of the 2018 VITA program is to have 6,000 error free returns electronically filed and accepted by the IRS. VITA sites must maintain a rejection rate of less than 9% to ensure quality.

### **Quality Reviewer Performance Accountability:**

The Quality Reviewer (QR) is essential to ensuring return accuracy and providing a quality tax preparation program. The performance accountability standards for this position require that the QR works to ensure the overall accuracy rate of their designated VITA site. The Quality Reviewer plays an active role in identifying and recording the most common errors made by the volunteers and reporting this information to the Site Coordinator (SC). This data assists both the QR & SC in providing the necessary coaching and resources to the volunteers in order to reduce rejection rates and to improve site performance. This position is also primarily responsible for ensuring that the privacy and confidentiality of client information is always maintained and safeguarded during the entire return preparation process.

#### **Performance Measures:**

- Examine every return prepared at the VITA site by completing Section C of the Intake and Interview sheet IRS Form 13614-C
- Review returns line by line with the client to answer any questions or concerns
- Make note of errors and issues that arise in the completion of returns and report findings to SC in order to improve accuracy rate and keep rejection rate down below 9%
- Collect all demographic and client satisfaction surveys from clients upon completion of the quality review process
- Advise the taxpayer that he/she is ultimately responsible for the information on the return before asking the taxpayer to sign Form 8879 or the return
- Support the SC and the Greeter with the setup and break down of the site
- Assist SC with site meetings to discuss quality review findings and provide mentorship support and resources to volunteers
- Ensure the provision of an excellent, customer focused, cost effective tax preparation service where the majority of requests are dealt with at the first point of contact
- All other duties as requested by program management

Also required for the position is the Form 13614-C Intake/Interview and Quality Reviewer training, Cancellation of Debt and Health Savings Account certifications. Excellent communication skills are a must; bilingual a plus (English/Spanish, English/Creole, English/Portuguese).

Must have a valid driver's license and appropriate insurance or be able to secure a valid Florida driver's license/insurance at the time of employment for this position.
